NOMINATION PETITION - COUNCILMEMBER

TOWN OF PARKER, COLORADO

The following is a form nomination petition to become a candidate for the office of Councilmember in the Town of Parker, Colorado, at the Town of Parker regular municipal election to be held on November 3, 2020. Three (3) Councilmembers will be elected.

To be effective, the petition must contain the signatures and residential addresses of not fewer than twenty-five (25) registered electors who reside within the Town of Parker, Colorado. The petition may be circulated for signatures no sooner than ninety-one (91) days before the election (August 4, 2020), nor later than seventy-one (71) days (August 24, 2020) before the election. The completed petition must be submitted to the Town Clerk during normal business hours on or before August 24, 2020.

Pursuant to Section 2.5 of the Town of Parker Home Rule Charter, the three (3) candidates for Councilmember who receive the highest number of votes cast at the election will each be elected to a four-year term of office.
